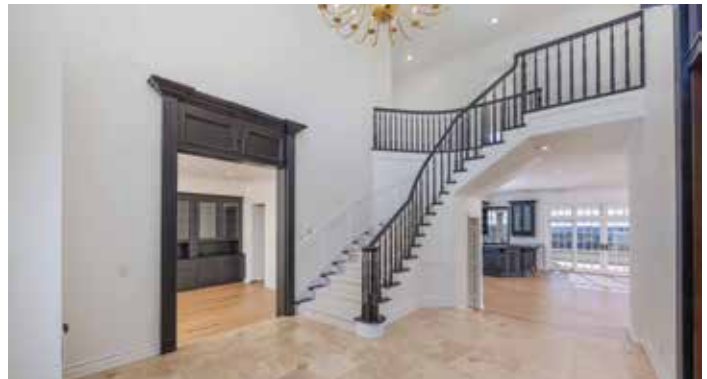

DISNEY'S ALADDIN OPENS MAY 7 AT SEGERSTROM CENTER FOR THE ARTS IN COSTA MESA

The Costa Mesa return of Disney's Aladdin opens May 7 at Segerstrom Center for the Arts for a limited engagement of one week, through May 12. In Costa Mesa, Aladdin will play Tuesday through Friday at 7:30 pm, Saturday at 2 pm and 7:30 pm, and Sunday at 1 pm and 6:30 pm.

Tickets to Aladdin are available at the Segerstrom Center for the Arts Box Office, by phone at (714) 556-2787, and online at scfta.org. Ticket prices for the engagement start as low as \$49.

About Aladdin

Aladdin, the hit musical based on the Academy Award®-winning animated film, opened on Broadway at the New Amsterdam Theatre to critical acclaim on March 20, 2014 and quickly established itself as one of the biggest new blockbusters in recent years. Having played over 3,000 performances, the New York production is among the Top 20 longest runs in Broadway history.

Produced by Disney Theatrical Group, under the direction of Andrew Flatt, Anne Quart and Thomas Schumacher, Aladdin features music by Tony Award and eight-time Oscar® winner Alan Menken (Beauty and the Beast, Newsies, Sister Act), lyrics by two-time Oscar winner Howard Ashman (Beauty and the Beast, The Little Mermaid), three-time Tony Award and three-time Oscar winner Tim Rice (Evita, Aida) and six-time Tony Award nominee Chad Beguelin

SET THESE 10 DOCTOR-RECOMMENDED HEALTH GOALS

Is it time to hit the reset button on your health and wellness? Not sure where to start? Doctors say you can make the biggest impact with small, incremental tweaks to your routine.

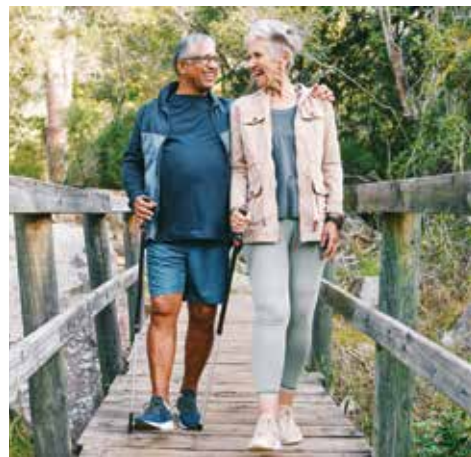
"It is quite common to set big-picture, ambitious health goals," says Jesse M. Ehrenfeld, M.D., MPH, president of the American Medical Association (AMA). "But the good news is you don't have to make major changes in one fell swoop; small, positive health choices made right now can have long-lasting effects."

Want to get started today? Here are the 10 goals the AMA recommends top your list:

1. Get moving. Exercise is essential for your physical and mental health. The American Heart Association recommends that adults get at least 150 minutes a week of moderate-intensity activity, or 75 minutes a week of vigorous-intensity activity. Just can't get to the gym? No problem: start off by going for a family walk, taking the stairs at work or parking a little farther away.
2. Tweak your diet to include more water and less sugar-sweetened beverages. Replace processed foods -- especially those with added sodium and sugar -- with nutritious, whole foods. Stock your fridge and pantry with fruits, vegetables, whole grains, nuts and seeds, low-fat dairy products, and lean meats and poultry.
3. A number of respiratory viruses circulating this winter can be serious and even life-threatening. Get up to date on your vaccines to protect yourself and your family. These include the annual flu shot and the updated COVID-19 vaccine for everyone 6 months and older. Vaccines are also available to protect older adults from severe RSV. New tools to protect infants

during RSV season include maternal vaccination and monoclonal antibody immunization. If you have questions, speak with your physician and review trusted resources, including getvaccineanswers.org.

4. Get screened. Estimates based on statistical models show that since April 2020, millions of screenings for breast, colorectal and prostate cancer may have been missed due to pandemic-related care disruptions. MERV GRIFFIN'S LA QUINTA ESTATE OFFERED FOR SALE AT \$36 MILLION



A man of many accomplishments but best known as the creator of game shows Jeopardy and Wheel of Fortune, Merv Griffin was a multi-talented entertainer whose career spanned six decades. The California native got his start as a big-band singer, earning enough from touring to start his own record label. He hit it big in 1950 with the #1 box office hit "I've Got a Lovely Bunch of Coconuts."

At a nightclub performance, he was discovered by Doris Day and appeared in several movies in 1954. Disillusioned by Hollywood, he bought out his contract from Warner Brothers and devoted himself to a then-new medium: television. He hosted and produced several game shows, including Play Your Hunch, Jeopardy, and Wheel of Fortune, before launching his own talk show in 1965. The Merv Griffin Show ran for 21 years and garnered 11 Emmys. In 1986, when he retired and sold his production company, Merv Griffin Productions, to Columbia Pictures Television for \$250 million, he was declared Hollywood's richest performer. He died in 2007 at the age of 82.

Merv Griffin's La Quinta estate is as legendary as the man. Offered for sale at \$36 million, the truly unique property spans 40 acres and includes

seven separate residences. A blend of California modern and Moroccan influences, it was inspired by Yves St. Laurent's Marrakesh home and designed by noted Los Angeles interior designer Waldo Fernandez.

The estate's crown jewel is the stunning 5,409-square-foot main residence. An airy-open floor plan, bright white walls, wood accents, and Moroccan-inspired lamps complement the fantastic views of the surrounding mountains and private lake. One of Hollywood's most popular performers and longtime friend with people like Ronald and Nancy Reagan, Robert Loggia, Eva Gabor and Zsa Zsa Gabor, Merv was a frequent party host adding 500-square-foot pods to offer intimate housing for guests. Two additional homes, the West Building and the Gate Building at 1,568 and 1,708 square feet respectively, provide additional housing for guests or staff.

The extensive grounds offer manicured lawns, tall palm trees, and an expansive orchard with oranges, grapefruits, lemons, limes, pomegranates, and guavas, as well as the iconic King Fig Tree, one of the largest in the Coachella Valley. The tranquil Lake Merveilleux is filled with koi, turtles, and bass and attracts numerous migratory birds.



Professional equestrian facilities with top-of-the-line stables, a racetrack, a pool, and a six-bay garage complete the estate. Surrounded by towering twelve-foot walls, the compound is private and secure.

La Quinta is a desert resort city in California's Coachella Valley, best known for the La Quinta Resort and Club, which hosts the Bob Hope Chrysler Classic PGA golf tournament. The Griffin estate is surrounded by some of the world's best golf clubs, with nine courses designed by professional golfers, including Pete Dye, Greg Norman, Jack Nicklaus, Tom

Weiskopf, and Arnold Palmer within a fifteen-minute drive. These courses have made the community a celebrity vacation hotspot, hosting a who's who of the rich and famous since 1926, including Shirley Temple, Frank Capra, Bill Clinton, Gwen Stefani, and Justin Bieber. Residents include Lori Loughlin, Cindy Crawford and Rande Gerber.

Taste of Wine & Food

CORI TRATTORIA PASTIFICIO, A THREE FORK GAMBERO ROSSO AWARDEE

Accursio Lota, Executive Chef/Owner of Cori Trattoria Pastificio in North Park, San Diego, leads a family-operated Southern Italian restaurant with a focus on Sicilian cuisine. Celebrating four years in business, Cori recently earned a place in the esteemed "Top Italian Restaurant 2024 Guide" by Gambero Rosso, likened to a Michelin achievement in Italy's culinary world. Gambero Rosso, known for its discerning palate, has meticulously selected restaurants for its guide since 1986. Awarded on a three-point scale symbolized by a fork, Cori proudly boasts a three-fork distinction, signifying excellence in authenticity, service, and wine selection, placing them among 30 globally and one of five in the USA. Furthermore, Cori recently underwent a stunning makeover, blending their Italian Trattoria with a 1960s flair, in collaboration with Interior Designer Graham Strickler, injecting vibrant energy into the space and enhancing the Sicilian dining experience, perfectly capturing the essence of San Diego, California. Accursio's core team includes Sommelier Federico Cavalleri, Chef de Cuisine Jorge Ceron, and Lead Server Ben Vasiliou.

At our onsite review, we learned that Accursio started his culinary skills in Italy at the young age of 14, as part of a trade school program. He loved applying his learnings when cooking with his mother and grandmother along with appreciating farm to table quality from his grandfather who was a farmer. His other grandparents owned

a grocery store so any ingredients not on the farm were readily available at his grandparents' store.

Accursio created an over the moon tasting menu allowing us to sample at least one item from each of the menu sections. For appetizers, we had Lumache, braised escargot in a marinara sauce with a mint battuto, and garlic confit. I was surprised to see escargot on the menu, being an Italian vs French restaurant. Leave it the Sicilians, the escargot, was heavenly. We also had Arancini – crispy rice balls, fried golden brown, and infused with mushrooms, mozzarella, and gorgonzola cheese. A crock of whipped up Pecorino cheese sauce accompanied the Arancini. Our third appy was Eggplant Parmigiana fried whole and topped with cherry tomatoes and baked cheese. At Frederico's suggestion, we both had the Etna Rosso DOC Navigable Nerello Mascalese/ Nerello Cappuccio blend. The volcanic based soil helped to produce a nice cherry palate, but was not overpowering. Frederico's goal is to source and share native Italian wines with customers from small producers with a focus on Sicilian wines. He loves to find obscure, esoteric varietals and avoids well known Italian wines such as Chiantis and Super Tuscans.

Accursio shared that Cori's menu is updated a few times per year. About 30% of the menu items change, 20% are favorites and stay the same including their lasagna, my favorite item we tasted. The other 50% are protein based, but the entrees change based on seasonality

to incorporate farm to table vegetables. Additionally, all pasta is handmade and extruded at their restaurant, including gluten free options. We were able to enjoy a couple of the pasta dishes during our main (Secondi) portion of our tasting menu. We were spoiled with one of Cori's most popular dishes, their lasagna with a bechamel angus beef and pork Bolognese. House made spinach pasta is used for the noodles to create 7 layers of heavenly lasagna. In addition to the lasagna, we also had the Kabocha squash and duck confit ravioli with savory flavors including sage. Our third main item was the Brasato, 18 hours braised short ribs in a caramelized mushroom sauce. The short ribs were topped with a timbale onion. Our server Ben, shaved dark chocolate over the dish tableside. The melt in your mouth ribs perfectly rounded out our main

dinner item parade. We both paired the main entrees with Montefalco Rosso, a 2016 Sangiovese/Sagrantino blend from Umbria.

Dinner concluded with Ruota Menfitana - Accursio's hometown ruota shell ruote, filled with sheep ricotta, candied oranges, pistachio, prickly pear juice and Mousse al Limone e Mirtilli - lemon mousse, local passion fruit, blueberry, bitter orange jam, and meringa.
